APPROVAL PROCESS: LMVA Village Improvement Project (VIP) Committee will review each application and designs and approve to ensure consistency. Businesses are to submit a PDF file of the design in accordance with the timeline on the schedule.

BANNER DISPLAY FEES: The LMVA is responsible for the installation of the banners. The display fees are as follows:

- Events Banners: Rental Cost \$100.00 (30 days) + Build Cost \$57.00 + Banner Installation \$16.00 (per banner) = \$173.00 per event
- Business Banners (banner can be split with another business): Rental Cost \$300.00 (90 days) + Build Cost \$57.00 + Banner Installation \$16.00 (per banner) = \$373.00 per business

Full payment of the Banner Fees are due upon approval of the design to reserve space. Banner locations can be requested, but not guaranteed.

BANNER PROGRAM DETAILS: All businesses are responsible for complying with all LMVA requirements regarding content. Banners are for branding purposes only. They are not for promoting products and advertising. If a business is sponsoring an event for brand recognition, the brand can be used but is regulated by the LMVA restrictions. Business logos are restricted to 90% of the total banner area. There are No (1) commercial, religious or political messages allowed, (2) tag lines allowed, (3) phone numbers, addresses, email addresses and websites allowed and (4) traffic wordage such a "Stop" or "Yield" allowed.
